All types of registrations must include proof of registration with the Nebraska Department of Labor.

All information contained in this application is true and correct. I will notify the City of Blair of any changes in the information reported on or with this application form within 15 days of the change.

I hereby make application to the Licensing Board of Blair, Nebraska and certify that I am competent and experienced to engage in above said vocation.
